WOMEN VETERANS THANKED DURING WOMEN'S HISTORY MONTH

It took years to make the military fully accessible to women. Legislation formally allowing women into the military was passed in 1948 (even though tens of thousands served in both world wars, and a number served in the Civil War as nurses, spies, and even soldiers disguised as men).

Today's military is much more integrated along gender lines than at any time in the past. Women are no longer excluded from any type of combat mission. They are pilots, infantry and armor officers, vehicle drivers, mechanics, and nurses. Percentages of women service members have roughly doubled in the last generation for the various services, but averaged across the four major Department of Defense services, women represent only one of every six Americans in uniform, ranging from about 8 percent in the Marine Corps to 19 percent in the Air Force. While the U.S. military has never had a higher fraction of women, they remain just 16 percent of the total force.

Women in senior leadership roles are a much lower percentage. Only six women have reached four-star rank out of roughly 100 4-star military personnel. General Ann Dunwoody of the U.S. Army became the first in 2008, the first woman to serve as a 4-star general in both the Army and the U.S. armed forces. Other notable women "warriors" are:

Grace Hopper, who became the third programmer of the world's first large-scale computer called the Mark I. Her importance in U.S. naval history is apparent with a destroyer named after her (USS Hopper, DDG-70) and the Cray XE6 "Hopper" supercomputer. As founder of the COBOL programming language, a precursor to many of the software code approaches of today, her work is legendary among computer scientists and mathematicians. She coined the term "bug" for computer issues. In 1983, a bill was introduced to promote her to rank of Commodore. The bill was approved by the House, and at the age of 76, she was promoted to Commodore by special Presidential appointment. Her rank was elevated to rear admiral in November 1985, making her one of few women admirals in the history of the United States Navy.

Born a slave near Jefferson City, Missouri, Cathay Williams was the first known African American woman to serve in the United States Army-enlisting under the name "William Cathay" to hide the fact she was a woman. Documents show Williams served alongside the men in her unit-without being recognized as a woman- until she contacted smallpox and became ill. The disease caused her to be in and out of military hospitals until it was discovered she was female and immediately discharged.

To all our women veterans, "Thank you for your service."

NFRW KEEP NINE CALL TO ACTION

"Nine seems to be a good number."

So said the Late Supreme Court Justice Ruth Bader Ginsberg in a NPR interview in 2019 regarding speculation about expanding the number of justices on the Supreme Court, also known as court-packing.

Many Americans are surprised to learn the number of justices serving on the Supreme Court of the United States is not fixed in the Constitution. America has had nine justices on the Supreme Court since 1869, and most would say it's worked well in maintaining the checks and balances in our government.

So why would anyone want to change that? The answer is simple - blatant partisan politics. There are politicians who want to use the Supreme Court to green-light policies initiated by the President through the back door of our court system when they can't get them passed in the Legislature. Expanding the number of justices, they feel, would aid in that process.

Court-packing is not a new concept. President Franklin Delano Roosevelt tried to expand the number of Supreme Court Justices in an attempt to push through more of his New Deal policies. Even members of Roosevelt's own party thought this scheme would undermine the independence of our judiciary and pose a threat to the separation of powers among our three branches of government. He abandoned the idea.

Why fix what isn't broken in the first place?

Liberal politicians and left-wing advocacy groups, however, are revisiting the concept. Frustrated by the ideological balance of the current Supreme Court - particularly with confirmation of President Trump's nominees Justices Neil Gorsuch, Brett Kavanaugh, and

Amy Coney Barrett - these activists are demanding that "the Supreme Court needs to be fixed and balance restored."

Fortunately a bipartisan group composed of members of Congress, senators, and state attorneys general has emerged to set nine as the number of justices on the Supreme Court through an amendment to our Constitution. The "Keep Nine" amendment states simply: "The Supreme Court of the United States shall be composed of nine Justices." This amendment to the Constitution was introduced in the House of Representatives by Rep. Dusty Johnson (R-SD) as H.J.Res.11. Over 60 members have signed on as supporters. Senator Ted Cruz (R-TX) recently introduced a companion proposal, S.J.Res.9, which he described as "preserving the integrity and independence of the Court, and protecting Americans' constitutional liberties."

Now more than ever we as Americans need to preserve the independent nature of the Supreme Court. Court-packing completely undermines the separation of powers as written in the U.S. Constitution.

I urge our "NFRWarriors" to get behind this important constitutional amendment. To help this gain traction, I recommend the following action items:

- Ask your U.S. senators to support S.J.Res. 9.
- Ask your U.S. representatives to sign onto H.J.Res. 11.
- Ask your governor to issue a statement of support for the Keep Nine Amendment.
- When contacting your elected officials, ask them to issue a public statement supporting the Keep Nine Amendment.

The Whittier Museum has a special room dedicated to President Nixon, 37th President of the United States, who was raised in Whittier, attended East Whittier Elementary School, Whittier High School, Whittier College, and started his law practice in Whittier. The Hubert Perry Family, Nixon's first political supporters, helped us remodel the Nixon Exhibit Room in 2018.

We received a call several months ago from a Nixon Collector in Pottstown, Pennsylvania who has an incredible collection of Nixon campaign memorabilia. He has offered to donate this entire collection to us. We were sent a photographic list of what is in his collection. His only request was that the collection be packed by professionals to insure its safe travel. H.R. 1: YOUR VOICE IS NEEDED!

Please Tell Your Senators **Not** to Support the
"For the People Act"

The Left is calling H.R. 1, the deceptively named **For the People Act**, a "voting rights bill." But it is not. It is a partisan, federal takeover of the election process and would reduce the security of future elections. It weakens states' involvement in federal election oversight and threatens their sovereignty.

It would also make all voter I.D. laws unenforceable, nationally, and would virtually eliminate any restrictions on vote-by-mail which greatly increases the opportunity for voting irregularities. H.R. 1 assaults our First Amendment right to free political speech by making the personal information of citizens who contribute to non-profit organizations available in a searchable government database.

Imagine contributing to a non-profit organization as a private citizen and then being harassed and intimidated by individuals or groups who disagree with you because H.R. 1 allows them to access your personal information!

The House of Representatives already passed this horrible bill and now the Senate is our last hope to legislatively stop it. Please contact your Senators today and tell them not to vote for the For the People Act.

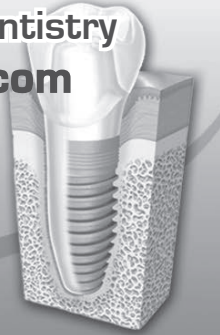
